TERMS AND CONDITIONS AGREEMENT

Please review, sign and date Maplewood School's 2025-2026 terms and conditions agreement.

SIGNATURE, REGISTRATION FEE AND DEPOSIT ARE REQUIRED TO PROCESS ENROLLMENT.

1. Tuition is paid in 10 monthly installments. Payments are to be sent to the school on the first of every month. We accept checks, credit cards and ACH payments. A 3% confidence fee is added to all credit card payments.
2. Tuition payments are the same each month regardless of the number of school days in the month. If tuition is not paid in a timely manner, enrollment will be disrupted until account is made current.
3. The parent \guardian who signs this enrollment form represents that he\she has full authority to do so and will be responsible for payment of all fees.
4. In the event of delinquent payment, I agree to pay any legal fees incurred in the collection process.
5. If you have two children, the second child will receive a 10% discount.
6. It is understood that no refunds will be made for school closings, (this includes quarantine periods) sickness, withdrawals or other absences except as outlined in the "make-up day plan".
7. Permission is hereby granted to take my child on educational field trips without further consent.
8. Permission is hereby granted for Maplewood School to provide routine health care.
9. In the event that a parent cannot be contacted, the parent gives permission to hospital or doctor to administer emergency treatment to child.
10. It is understood that all photography or video taken at Maplewood may be used for promotional purposes or in other ventures directly relating to the school.
11. It is agreed that any dispute concerning, relating, arising out of or referring to the subject matter of this contract shall be resolved exclusively by binding arbitration in Nassau County, New York according to the existing commercial rules of the American Arbitration Association and the substantive laws of that state.
12. I understand that my child must be fully toilet trained and that diapers and pull-ups are not allowed.
13. It is understood that a current health form with immunizations must be on file before my child's first day.
14. Maplewood reserves the right to dismiss a student whose conduct or influence, in the opinion of the Director, is not in the best interest of the school or the child.
15. Assumption of Risk: I understand that part of the school experience involves activities and interactions that may be new to my child, and that they come with certain risks and uncertainties beyond what my child may be used to dealing with at home. I am aware of these risks, and I am assuming them on behalf of my child. I realize that no environment is risk free and so I have instructed my child on the importance of abiding by the school's rules and policies, and my child will obey them. Maplewood is not responsible for events beyond it's control, epidemics, acts of third parties, insect transmitted diseases, etc. Maplewood is not responsible for injuries to the student which may occur during the ordinary course of school activities.
16. A non-refundable registration fee of \$50.00 and a deposit of \$100.00 is required to process enrollment.
