TERMS AND CONDITIONS AGREEMENT

Please review, sign and date Maplewood's 2026 terms and conditions agreement.

SIGNATURE AND DEPOSIT ARE REQUIRED TO PROCESS ENROLLMENT.

1. A deposit of 1,000.00 per camper is required to enroll. Additional payments of \$750.00 each are due on December 10th and February 10th. Tuition balance is due in full on April 1, 2026. A 3% service fee will be applied to all credit card payments.
2. Payments are refundable until April 1st minus a \$200.00 cancellation fee. After April 1st a \$500.00 service charge will be applied.
3. There are no refunds for any reason after June 22, 2026.
4. If you have two children, the second child will receive a 5% discount. If you have three children attending the first child is full price, the second will receive a 10% discount and the third child will receive a 20% discount.
5. The parent, guardian or person who signs this agreement represents that he\she has full authority to do so and is responsible for payment of all camp fees.
6. We reserve the right to cancel this registration if fees are not paid in full by April 1st, or if any unforeseen circumstances should arise.
7. In the event of delinquent payment, you agree to pay all costs incurred during the collection process, including legal fees.
8. Maplewood will be closed on Friday, July 3rd. Credits will not be given for camp closings, absences, family vacations, transportation delays or withdrawals. No make-up days.
9. Maplewood reserves the right to dismiss a camper whose conduct or influence, in the opinion of the Director, is not in the best interest of the camp or the camper.
10. In the event that a parent cannot be contacted, the parent gives permission to a hospital or doctor to administer emergency treatment to child.
11. Consent is given for routine health care.
12. Consent is hereby granted for transportation to and from any and all camp activities and programs.
13. It is understood that all photography or video taken at Maplewood may be used for promotional purposes or in other ventures directly relating to the camp.
14. It is agreed that any dispute concerning, relating, arising out of or referring to the subject matter of this contract shall be resolved exclusively by binding arbitration in Nassau County, New York according to the existing commercial rules of the American Arbitration Association and the substantive laws of that state.
15. Assumption of Risk: I understand that part of the camping experience involves activities and interactions that may be new to my child, and that they come with certain risks and uncertainties beyond what my child may be used to dealing with at home. I am aware of these risks, and I am assuming them on behalf of my child. I realize that no environment is risk free and so I have instructed my child on the importance of abiding by the camp's rules and policies, and my child will obey them. Maplewood is not responsible for events beyond it's control, epidemics, acts of third parties, insect transmitted diseases, etc. Maplewood is not responsible for injuries to the camper which may occur during the ordinary course of camp activities.
16. I understand that my child must be fully toilet trained and that pull-ups are not allowed.
17. Maplewood complies with all Nassau County Department Regulations. Maplewood's operating permit is provided by Nassau County Department of Health. The operating permit and inspection reports are on file at 200 County Seat Drive, Mineola, NY 11501. Health Department hours of operation are 9:00am – 4:00pm. Maplewood is required to be inspected twice yearly.
18. Camp operators are required to: 1) inform parents and the local health department of serious injuries, illness or abuse incidents 2) screen the background and qualifications of all staff and train staff about their duties 3) provide supervision for all campers during hours of operation 4) maintain all camp physical facilities in a safe and sanitary condition 5) provide safe and wholesome meals 6) have and follow required written plans for camp safety, health and fire safety.
